

Planet Doggiewood Owner Agreement

I, _____, hereby certify that my dog(s) _____

_____ is/are in good health, on a monthly flea and tick prevention and have not been ill with any communicable condition in the last 30 days. I further certify that my dog(s) have not harmed or shown aggressive or threatening behavior towards any person or any other dog. If my dog arrives with fleas or ticks, my dog will be bathed and treated at my expense.

___ 1. I understand that I am solely responsible for any harm or damage caused by my dog(s) to persons or property or the owners, employees, licensees, guests of Planet Doggiewood, or any other pets housed or visiting Planet Doggiewood while my dog(s) is/are attending Planet Doggiewood. Should my dog exhibit inappropriate aggressive behavior toward other dogs or people, for the safety of all concerned, my dog will be placed in a secure dog run.

___ 2. I understand that Planet Doggiewood agrees to exercise due diligence in the care of my dog(s). In addition, Planet Doggiewood agrees to keep its premises sanitary and properly enclosed. Therefore, I agree that Planet Doggiewood LLC, and their staff and volunteers, will not be liable for any problems which develop, provided reasonable care and precautions are followed, and I hereby release and discharge them of any and all damages, liability and/or losses from disease, theft, fire, death, escape, injury or harm to persons, other dogs or property by my dog, or from other unavoidable causes whatsoever arising from my dog(s) attendance and participation at Planet Doggiewood.

___ 3. I further understand, consent and agree that any problem or injury that develops with my dog(s) while under the control of Planet Doggiewood, will be treated by my own Veterinarian. In the event my own Vet is not available or too far away (if it was an emergency) I agree to let the Vets and staff at the animal hospital of Planet Doggiewood's choice, or the Animal Emergency Hospital may treat my dog. I agree to assume full financial responsibility for any and all expenses involved in such treatment.

___ 4. I recognize that there are inherent risks of illness or injury when dealing with animals. Dogs use their mouths and paws to play and have sharp teeth and nails. Such risks include, but are not limited to, problems resulting from rough play.

___ 5. I am aware that my dog will commingle with dogs owned by different owners while staying at Planet Doggiewood.

___ 6. I agree that my dog may be videotaped, photographed, and/or recorded. Planet Doggiewood shall be the exclusive owner of the results and all such tapings, photography, and recordings will be used only by Planet Doggiewood in its own promotion, advertising, sale, or publicizing.

___ 7. I understand that Planet Doggiewood reserves the right to refuse any dog.
